If your case appears on this calendar, you are required to attend the trial week on **December 6, 2021, at 8:30 a.m.** in the Courtroom of the Superior Court of Morgan County, Madison, Georgia.

There will be no calendar call prior to trial week but you may efile your announcement with PeachCourt and send a copy to Molly Bonner at bonnerm@eighthdistrict.org. When identifying your case, please refer to the page and item number listed on the calendar. Conflict letter or leave of absence will not relieve you from making an announcement to court. **Any requests for a continuance need to be directed to Judge Stephen A. Bradley's office.**

The announcements to be made are READY, NON-JURY, REQUEST CONTINUANCE OR NOT READY. If you announce "request continuance" or "not ready," you will need to submit a detailed explanation for that announcement. **If you announce Non-Jury, all attorneys will need to sign a Waiver of Jury Trial.**

If you cannot attend the Trial Week, you must notify the Court and be excused prior to the date of the Trial Week. If a party fails to appear or be excused by the Judge, the Court may dismiss without prejudice the Plaintiff's action or Defendant's answer, counterclaim, or cross-claim.

IF YOUR CASE HAS SETTLED, DISMISSED, OR TRIED, ALL FINAL ORDERS AND DISPOSITIONS (INCLUDING FINAL DISPOSITION FORMS PER O.C.G.A. 9-11-58) MUST BE FILED WITH THE CLERK OF MORGAN COUNTY NO LATER THAN THE WEDNESDAY PRIOR TO THE BEGINNING OF THE TRIAL WEEK.

Unless you have been otherwise instructed, all juries will be picked on Monday for any cases tried during the trial week. It is YOUR responsibility to stay in contact with the Judge's office to determine your case's position, whether you need to be ready to pick a jury on Monday, if the Court has determined no jury panel will be brought in, if criminal cases will take priority over civil cases, and to advise the Court of the possible length of time required to try your case.
