The calendar will be called and guilty pleas will be taken on **Thursday, September 30, 2021 beginning at 9:00 a.m.**

Cases not pled on the date listed will be tried in an order directed by the Court. Counsel in cases older than one year should assume their cases will be tried during the term. No continuances will be allowed without Court approval. Such approval will be given only in cases of manifest necessity as determined by the Court. **Any continuance request, shall be made by Monday, September 27, 2021. Attorneys shall notify the Clerk's office by 4:00 p.m. on Monday, September 27, 2021 of any plea that is to be entered** so that the files may be available to the Court.

**All defendants and their counsel must be present in person on the plea day, and personally present on the first day of the trial term Monday, October 18, 2021 starting at 9:00 a.m. unless that appearance is specifically excused by the Court.** Bench warrants shall issue for any defendants absent without prior approval of the Court. A bench warrant shall be issued for all Defendants who do not appear on time and as directed for the call of their case for trial. Further, failure to appear shall subject all counsel to punishment for contempt by the Court.

All Motions have to be filed, set for hearing, and heard in compliance with The Order Concerning Pretrial Motions in Criminal Cases of the Ocmulgee Judicial Circuit unless otherwise directed by this Court. Failure to strictly comply with this Order may result in Motions being untimely, abandoned and/or waived and therefore not considered. A copy of this order may be obtained by requesting same from the Clerk of Superior Court.
